About Application of Supply Installation Licence

Supply Installation refers to any electrical installation receiving electricity supply from its own generators.

Owner of all supply Installations in non-domestic premises, are required to apply for and obtain a licence to use or operate their supply installations.

Supply installation in individual residential premises are exempted from licensing if they are used exclusively for domestic purposes.

Supply installations are licensed to ensure that they are operated and maintained by licensed electrical workers and are safe to use.

Consumer is required to appoint an appropriate class of licensed electrical worker to take charge of his supply installation and submit application for supply installation licence through his appointed licensed electrical worker.



Electrical installation refers to any electrical wiring, fitting or apparatus used for the conveyance and control of electricity in any premises

Supply installation refers to any electrical installation receiving electricity supply from its own generators Electrical and Supply installations are licensed to ensure that they are operated and maintained by licensed electrical workers and are safe to use.



Electrical Installations A EMA licence is required to use or operate an electrical installation of approved load exceeding 45 kVA used for non-domestic purposes.

Electrical installations in premises used for "hazardous trades", irrespective of their approved loads, are also required to be licensed. Examples are motor paintshops, wood-working or saw-milling, petrol stations, paints and petroleum products, and temporary supply for building sites or engineering construction works. #### **Issue of Licences**

The licensed electrical worker shall login to the EMA web site to download the licence image and print and deliver the installation licence so printed to the consum<u>er within 5 working</u> days upon receiving notification from EMA. 
